WASHINGTON CONFERENCE SCHOOL EQUIPMENT MATCHING FUND

The Washington Conference policy allows equipment matching funds for all schools. The conference will match dollar for dollar up to one dollar per student enrolled. For schools with fewer than 20 students the conference will match up to a maximum of \$20.

Replacement items of portable athletic equipment (balls, etc.) will not qualify. This Matching Fund is made available to help schools purchase necessary school equipment. The church and/or school shall raise at least \$1.00 per student enrolled in order to be eligible. This will then make available to the school the combined church and conference allowance.

As soon as the church or school has raised a minimum of \$1.00 for each student enrolled, application may be made to the Education Department. This request must be accompanied by supporting invoices, vouchers, or receipts listing equipment purchased. Vouchers must reflect the total of the combined allowances of both the church and conference to be eligible. All applications for *School Equipment Matching Fund* must be made on this official blank. Do not send your share of the amount raised. The signature on this blank certifies that the required amount has already been raised. Only one application a year should be made by each school.
